**FURTHER ON MARKET PURCHASE OF CONVERTIBLE NOTES**

A wholly owned subsidiary of Dragon Mining Limited ("Dragon Mining" or the "Company") has purchased a further 179,451 Dragon Mining Convertible Notes ("Notes") at an average cost of \$1.03 per note for a total of \$185,444 including costs.
