FURTHER ON MARKET PURCHASE OF CONVERTIBLE NOTES

A wholly owned subsidiary of Dragon Mining Limited ("Dragon Mining") has purchased a further 70,000 Dragon Mining Convertible Notes ("Notes") at an average cost of \$1.05 per note for a total of \$73,702 including costs.

Of the 23,645,289 Notes on issue, 18,190,810 Notes are now held by the subsidiary of Dragon Mining. All Notes remain listed on ASX.

On 8 July 2010, Dragon Mining announced the early redemption of all the outstanding Notes in October 2010, being the next interest payment date.
